Bylaw change for consideration at Unit Meeting May 2, 2015

On September 4, 2014 the WA Unit Board of Trustees approved to send to the membership for consideration and vote the following motion to amend the WA Unit Bylaws. (*Proposed changes are in bold italics*)

Move to amend. **ARTICLE VIII –BOARD OF TRUSTEES AND ELECTION PROCEDURES**
Section 1. Board of Trustees

A. Board Composition. “The Washington Unit Board is composed of a President, a First Vice President, a Second Vice President *a Third Vice President*, a Corresponding Secretary, a Recording Secretary, an Assistant Secretary, a Treasurer, the immediate Past President and two Trustees.”

Section 6. When Officers are Unavailable. First sentence would read – “When the President, the *three (3)* Vice Presidents

Section 7. Succession When Vacancies Occur. “In the event of death or resignation of the President or the death, advancement or resignation of a Vice President, or the inability of an officer to fulfill the duties of office, the next ranking Vice President (in order of First, Second and *Third*) shall succeed thereto.”

(Approval of the motion would also require a new Section 4 under ARTICLE IX –Duties of Officers, describing the duties of the Third Vice President)

Rationale:

As it now stands, the newly elected Second Vice President must immediately start preparing for the next National Potlatch and Salmon Rally (the largest rally in Washington Unit’s Schedule).

The Potlatch rally host has a huge responsibility to organize this event with very little time to do so. A Third Vice President would have a whole year to learn and understand the culture of the unit and the expectations of hosting the largest unit rally before it becomes his/her duty.
