When members of the US Second Continental Congress approved the remarkable document known as the Declaration of Independence, they plainly declared their belief in God. The drafters of this noble proclamation knew that the sweeping freedoms they were proposing could work well only in a society where THE CREATOR is acknowledged. They affirmed that God has "endowed" all people with the right to "life, liberty, and the pursuit of happiness" because He values each of us.

Thomas Jefferson, who would become the third president of the new nation, was distressed by the sin he saw. He wrote, "*God who gave us life gave us liberty. Can the liberties of a nation be secure when we have removed a conviction that these liberties are the gift of God? Indeed I tremble for my country when I reflect that God is just, that his justice cannot sleep forever....*" (Inscribed on the Jefferson Memorial in Washington, D.C.) The founding fathers of the US loved the concept of individual freedom, but they did not have in mind a permissive lifestyle that allows us to do anything we please. True freedom can never be enjoyed by people who refuse to fear God.

The psalmist said, "Know that the Lord, He is God; it is He who has made us, and not we ourselves" (Psalm 100:3). We are responsible to God, because He has created us in love.
